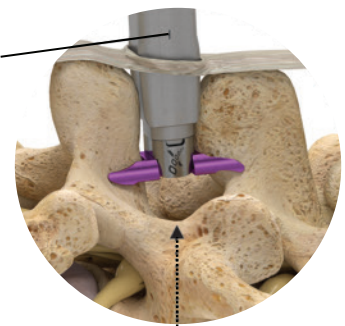
What is Superior®?

The Superior® device is a tiny titanium implant that is delivered through a tube the size of a dime. There is no removal of bone or tissue, and bleeding is minimal.

Superior® was developed for patients with spinal stenosis who have tried six months of conservative care treatment without finding relief from their pain. It is also for patients whose medical history shows that Superior® may be the best treatment option because traditional spinal surgery could be too demanding.



Small tube through which Superior® is inserted.



Superior® is placed between the vertebrae and holds them open. This relieves the pressure on the nerves in the spinal canal.

When the Superior® is placed, the device arms are opened and surround the spinous process. This ensures that the Superior® will not dislodge.
